

## Traffic Calming Working Group

Minutes 17.11.25

### 1. Primary School

- a. *LN advised that she awaited an update from David Hingley on the 11 identified areas for improvement to pedestrian safety at the School. DH is chasing Highways at OCC for a consolidated response. LN is keeping MP updated. It is proposed that Gladman's S106 monies that are targeted by the Inspector to address footways and crossing in the vicinity of the School are spent now rather than when development commences.*

### 2. Warriner/Bloxham Grove Academy

- a. *Meeting with Deeley at Warriner 12.11.25 with Warriner and BGA to address traffic issues in relation to development on Ells Lane.*
  - i. *Yellow lines will be implemented along Ells Lane from Crabtree to Wyatts*
  - ii. *A banksman will be employed to maintain site access for deliveries*
  - iii. *It is proposed that deliveries are restricted to 9 to 2.00pm to minimise impact on school traffic*
  - iv. *Deliveries will approach along the A361*
  - v. *Construction not expected before April 2026, but planning issues with CDC may delay the 18-month project*
  - vi. *Access to water for the site will be via the Crabtree mains access.*

### 3. VAS

- a. Replacements
  - i. *Schedule of existing plans reviewed. One potential change would be to move the David Tyrell sign south closer to the start of the 30-mph zone.*
  - ii. *Requests to be made for 'Angry Face' signs as these have more effect than a simple speed projection*
- b. Tadmarton Road
  - i. *Batteries changed, new data acquired*
  - ii. *Move to other side of road once foliage cleared*
- c. A361 David Tyrell
  - i. *Data secured, under analysis re DW application. Focus on busy time slots. General analysis suggests excess speeds are prevalent*

### 4. Yellow Lines Courtington Lane

- a. *No update on implementation so DH engaged to get a response*

### 5. Speed Watch

- a. Courtington Lane, A361
  - i. *Survey of trained users to establish when – needs to be monthly to retain the equipment*
- b. Equipment – Authority

- i. DB happy to volunteer but not lead. Handover of equipment – now with RAM.*

6. Pavement Parking

- a. RAM to contact Jo re copies of leaflet or leaflet improvement*
- b. Consider period of leafletting followed by Community Police engagement to reiterate message*
- c. A361 junction with Courtington Lane recognised as a pinch point at morning drop off. AH to raise with School.*

7. AOB

- a. Markings in place on entry to Bloxham School suggest that a pedestrian crossing may be implemented. We have no notification of this. AH to address with School.
- b. Equipment is in place on Barford Road for a traffic flow survey. Who is conducting this and why? RAM to investigate.
- c. Review of all open TCG issues with OCC for easier management going forward. Compile one control document and then seek a high-level review with OCC Highways to ascertain the way ahead. RAM to bring to December meeting
  - i. 20mph implementation
  - ii. Parking restrictions
  - iii. Replacement and locations of VAS
  - iv. Crossings at Primary School
  - v. Traffic calming on Tadmarton Road/Cumberford Hill
